

Construction Code Act

There is a new *Construction Code Act* that provincial building inspectors (PBI) will be following. An updated section of *The Construction Code Act* requires all residential dwellings (new or existing) to have smoke and carbon monoxide alarms installed by July 1, 2022. For further reading visit


Specific to smoke alarms:

- They are required: on each story, in each sleeping room, and in hallway within 5m of bedroom doors
- Buildings constructed prior to June 6, 1988 can have battery operated smoke alarms, must be 10 year sealed battery units
- Buildings constructed after June 6, 1988 must have smoke alarms hard wired and interconnected so that all alarms will sound

Specific to carbon monoxide alarms:

- They are required if the dwelling contains a fuel-burning appliance or a garage
- They are required: in each bedroom or within 5 m of each bedroom door
- Buildings constructed prior to October 1, 2009 can have battery operated carbon monoxide alarms, must be 10 year sealed battery units
- Buildings constructed after October 1, 2009 must have carbon monoxide alarms hard wired and interconnected so that all alarms will sound.

WHEN IS A BUILDING PERMIT REQUIRED?

- new building construction
- garages, carports and boat houses
- pole buildings (post-frame) or log buildings (must be designed under NBC Part 4)
- decks or raised platforms with any walking surface over 600 mm (24") above grade
- RTM, modular or manufactured/mobile homes (mobile homes are now called modular homes)
- renovations or alterations affecting structural members or life safety (egress windows for bedrooms)
- addition to an existing building
- basement development in a dwelling
- secondary suites (cannot exceed 80 m²) (860 ft²)
- accessory buildings, greenhouses, or gazebos greater than 10 m² (107 ft²)
- sunrooms (wood-framed and manufactured enclosures)
- fireplaces and wood stoves
- retaining walls (if their collapse could affect a structure or are built near a property line)
- foundation repair or replacement
- roof repair or replacement
- solar panels (roof mount) and ground mount panels if built near a property line
- change of building use or occupancy type
- tenant/leasehold improvements in commercial buildings
- temporary buildings or structures (fabric buildings/construction trailers/bleachers etc.)
- relocation of an existing building
- work to remedy an unsafe condition or fire official's order
- demolition of an existing building

BUILDING PERMITS ARE NOT USUALLY REQUIRED FOR:

- fences
- driveways, sidewalks and parking lots
- cosmetic upgrades or replacement not affecting structural or life safety
- accessory buildings, greenhouses, or gazebos not greater than 10 m² (107 ft²) in area
- some farm buildings (varies by rural municipality check local municipal bylaws)

Houses Numbers - Bylaw 2022-03

Lipton has introduced a bylaw stating that all houses must have numbers. As per sections 3, 4, and 5:

- 3. A separate number shall be assigned for each property, ascending from east to west and south to north as may be applicable as follows:
 - a) Even numbers to be located on the east and north side of the street; and
 - b) Odd numbers to be located on the west and south side of the street;
 - c) For every 7.5 meters (25 feet) of frontage; or
 - d) For every subdivided lot having a frontage measurement of other than 7.5 meters (25 feet).
- 4. Each house or building shall bear the number assigned to the frontage on which the front entrance is situated.
- 5. Notwithstanding section 4 of this bylaw, upon request of the owner of the property situated on a corner lot, the number assigned may be specific to the flankage where the front entrance is situated on the flankage side of the lot.

Sump Pumps

We have noticed a large increase in the lift station running that quite possibly is due to sump pumps being pumped into the sewer system. This is NOT ALLOWED. Please check your sump pumps in your homes and ensure the proper discharge water is being done. All water from sump pumps should be directed outside and NOT pumped into our sewer

Tenders must be submitted in the prescribed form and must be accompanied by a deposit of at least 20 % (percent) of the tender amount, which deposit shall be made by way of a certified cheque/bank draft/ money order payable to the municipality, and a description of the bidder's plans for the property ensuring the purpose meets the requirements in the Village's Zoning Bylaw.

Except as follows, the municipality makes no representation regarding the title to or any other matters relating to the lands to be sold. Responsibility for ascertaining these matters rests with the potential purchasers. The assessed value according to the last returned assessment roll may or may not be representative of the current fair market value of the property

This sale is governed by The Tax Enforcement Act.

The successful purchaser will be required to pay the full amount tendered plus accumulated taxes and any taxes or fees that may be applicable, including taxes and all title transfer and legal fees.

The Municipality has no obligation to provide vacant possession to the successful purchaser.
